1. CALL MEETING TO ORDER

An owner voiced his concerns with compliance enforcement being heavy handed. He noted the members voted down the issue with trash storage. He stated that he supports reasonable limits on enforcement.

An owner commented on her email to the Board regarding inconsistent language in the CC&R Amendment along with numerous typos. Judy noted this will be addressed.

Several comments were made regarding the Galena Country Estates Website and the EBMC portal. This will be reviewed and addressed.
