# Community Manager's Report

Mr. Berg said he spoke to Kern's office and a letter was sent to Lindsey who replied saying he will contact the county who has not responded yet. Kern's office said they will contact the county or Lindsey and get this moving along.

## CC&R and By-Law Amendment Update

Mr. Berg said there was a total of 108 responses out of 249. Mr. Crapo said they thought there would be more as they had a door-to-door campaign. He asked if they could get the ones out who did not respond and he also noted regarding the off-site homeowners. He also said they would let the Board take care of them page by page. Mr. Berg said paid postage would be a good idea as well as door to door. He said we could give them a list of who has not responded. Mr. Crapo said they have a spreadsheet with a tally and could reconcile with the new count. He said there is a high bar to achieve to change the CC&Rs and legally have to keep chipping away at it. Jaime Aranda said they have more success walking than depending on the mail as people tend to ignore HOA mail.

## Website Update

Mr. Grecu said they have not met since the middle of fall and Tania said the last place was waiting for an understanding of what they were supposed to do before they talked to them. In discussion of the feedback from Judy, they gave her the impression that there was supposed to be a lot more dialogue and Board meeting updates and minutes were supposed to be done in a timely manner, but if there is no documentation as to what they can do, it is hard to manage. Mr. Crapo asked if Kevin if he could find the agreement from Dragonfly Media. Ms. Williams said the challenge is that they are good and easy to work with, but that there is a communication gap or flow that needs to be reconciled. Mr. Berg asked if they could supply a template and Tania said the website is up but just out of date and there are some recommendations that they would like to make to revise it, but did not know who is supposed to communicate to them. Mr. Berg noted that a Board member would be ideal as management could possibly convey incorrect information. Ms. Williams said she would set up a call with John. Ms. Ganger said Holly used to email the Board minutes to Dragonfly media for information on the website. She did not know if there is an issue with this and someone would need to put these things up and Kevin said it would be between her and John after receiving the minutes from EBMC. Mr. Grecu said he and Tania will follow up.
