HOMEOWNER COMMENTS

COMMITTEE UPDATES

Architectural – it has been quiet, not much is going on for new architectural applications. One (1) committee member, Deanna Newcomb stated she isn't receiving the emailed submittals. Please confirm the email address and send a test email to her.

Firewise – C. Reed discussed the May 4th Montreux Firewise Event that our Firewise Committee was invited to attend. They were provided additional evacuation tips form the Nevada Department of Forestry which will be included in our handouts to homeowners. Also, some of the GCE Common Area designated in our CC&Rs were never transferred properly to GCE in 1985 from the developer; therefore, the Galena Country Estates Association may bot be able to have the NDF or TMFW thin out the wildland brush in the common area running along Mt. Rose Highway. In order to have a quiet title put in the associations name, LKG Law Firm estimates it will cost GCE approximately \$6,750.00 in attorney fees. At this time, the majority f the board does not want to spend money on the common area discrepancy issue.

LKG Law Firm responded to a letter from Washoe County/Eric Crump in regard to the landscape agreement between Galena Country Estates and The Reserve at Monte Rosa. The letter is on file and is confidential to the immediate parties listed on the letter. Any response from the county will be addressed by LKG Law Firm

Discussion on Fall Potluck Date/Fire Wise Event

C. Reed stated there will be more information to follow; the event will be tentatively September 14, 2024. Volunteers are needed in order to hold the event. The board is discussing food trucks and other ideas. Management will post a survey on TownSq to determine interest in having a potluck and volunteer availability. That information will be used to decide whether to proceed with the event.
